Boarding, Daycare & Grooming Agreement and Release

This is a contract between The Yellow Dog's Barn, LLC, a New Hampshire limited liability company with an address of 136 Old Concord Turnpike, Barrington, NH 03825, (The Yellow Dog's Barn), and the pet owner whose signature appears below ("Owner") for care of Owner's "pet". (The term "pet" refers to all pets boarding with the same ownership).

1. Owner agrees to pay the rate of boarding, daycare, grooming when applicable, in effect on the date pet is checked into The Yellow Dog's Barn and any additional fees for all ancillary services requested. Owner further, agrees to pay all costs and charges for special services requested by Owner or owner's agents. Payment may be made by Cash, Personal check, Visa, Discover or MasterCard. 50% of all charges are due upon check-in, with the remaining balance due on or before the date the pet is to be picked up. Checks that are returned are subject to a \$30.00 Service Fee and future appointments must be paid in Cash or Credit Card PRIOR to the start of your pet's next visit.

2. By signing this Contract and leaving his pet with The Yellow Dog's Barn, Owner certifies to the accuracy of all information given about said pet, that The Yellow Dog's Barn's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200 per animal.

3. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances. In accordance with State law, if Owner does not pick up the pet or pay charges and fees within 7 calendar days after the day the pet was due to be picked up, Owner shall be notified in writing of the intention to treat the Pet as abandoned and if Owner fails to pick up the Pet or pay charges and fees within 7 days of the mailing of such notification, the pet shall be deemed to be abandoned.

4. Owner is not aware of any medical reason or other reason why Owner's pet should not board, attend daycare, or be groomed at this time. Owner specifically represents to The Yellow Dog's Barn that the pet has not been exposed to rabies, distemper, parvo virus, or other contagious diseases within a thirty day period prior to arrival at The Yellow Dog's Barn. The Owner hereby certifies that the Pet is current on Rabies, Distemper and Parvo-Virus, Bordetella, as applicable. Proof of Vaccination or current Titer testing shall be provided to The Yellow Dog's Barn upon request. Owner is aware that by leaving their pet at The Yellow Dog's Barn, or any other pet facility, their pet is at a higher risk of contracting kennel cough, viruses, or acquiring nicks, cuts, and possibly punctures, and is holding The Yellow Dog's Barn harmless of any resulting medical care. While we have taken very special care in designing our facility and maintaining a high level of cleanliness and safety, no vaccine is 100% guaranteed.

5. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, The Yellow Dog's Barn, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the pet, and the expenses thereof shall be paid by Owner. Owner authorizes The Yellow Dog's Barn to obtain medical records from Owner's veterinarian in the event of a medical emergency. Owner understands that Owner must immediately contact The Yellow Dog's Barn and update the information on this form should the Emergency Contact, medical or any other critical information change. This agreement remains in effect until owner/owner's agent asks to change it.

If my pet requires medical care during their stay, I authorize The Yellow Dog's Barn to do the following (**initial each statement**):

_____ I authorize The Yellow Dog's Barn, LLC to do whatever is necessary for the health and well-being of our Pets and agree to pay for any and all such expenses. If medical attention is needed The Yellow Dog's Barn, LLC will make every effort to contact the owner or owner's emergency contact. If the owner or emergency contact is unreachable and an immediate decision must be made The Yellow Dog's Barn, LLC has my permission to make that decision.

_____ Do what The Yellow Dog's Barn and the veterinarian of their choice deems necessary to try to maintain my pet's health. I will be responsible for all costs.

_____ Do NOT provide medical treatment in excess of \$_____ at The Yellow Dog's Barn's veterinarian of choice. I understand that by selecting this option I release and hold harmless The Yellow Dog's Barn from all liability resulting from the inability to exceed the specified amount for medical treatment. I will be responsible for all costs.

6. Owner agrees that Owner is solely responsible for any harm or damage caused by Owner's Pet(s) to persons or property of the Owner's, employees, and invitees of The Yellow Dog's Barn, LLC, or any other pets housed or visiting The Yellow Dog's Barn, LLC while Owner's Pet(s) is/are attending The Yellow Dog's Barn, LLC.

7. Owner acknowledges and understands that there are certain risks involved in pet ownership, training, grooming, and care, including, but not limited to, dog fights, dog bites to humans and/or other pets and the transmission of diseases. With owner's signature below, he/she understands the risk involved in putting his/her pet in a cage-free environment and acknowledge and accept exclusive and sole responsibility for all medical expenses to said pet no matter the cause. Owner also authorizes the release of said pet's medical records from pet's veterinarian.

8. Release and Covenant Not to Sue. The Owner hereby releases, waives, discharges and covenants not to sue The Yellow Dog's Barn, its members, officers, employees, volunteers, laborers, contractors and agents, all of whom for the purposes of this Release are referred to as "Releasees" from all liability to the Owner and the Owner's personal representatives, assignees, heirs and next of kin, for any and all loss or injury to the persons or property, including the Pet, of the Owner or resulting in the death of the Owner's Pet, whether caused by the negligence of the Releasees or otherwise.

9. Indemnification. The Owner shall indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage or cost, including attorney fees, from any and all claims, causes of action, losses, damage, liabilities, costs and expenses, including attorney fees, arising from the death of or injury to any person, from damage to or destruction of property, including pet(s), arising from the provision of services by the Releasees.

10. Owner has read the attached Rules and Regulations and agrees to abide by them. Owner certifies that Owner has read and understands the Rules and Regulations set forth on the preceding page and that Owner has read and understands this Agreement and Release. I agree to accept all the terms, conditions, and statements of this agreement.

11. This contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and The Yellow Dog's Barn.

12. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration conducted upon such terms and conditions as the parties, acting reasonably and in good faith, may agree. In the event the parties cannot agree as to an arbitration format, the matter shall be submitted to arbitration in accordance with rules promulgated by the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of this award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party. This shall not alter The Yellow Dog's Barn's right to treat the Pet as abandoned under section 3 above.

By signing this contract, the signer represents that he/she is the Pet Owner, or Owner's Agent and is the responsible party for these Pet(s). All terms and conditions of this contract shall be binding on the heirs, successors, administrators, personal representatives (agents) and assigns of Pet Owner and The Yellow Dog's Barn. By signing this contract and leaving pet with The Yellow Dog's Barn, LLC, owner certifies to the accuracy of all information given about the pet. Furthermore, owner has read and understands all procedures and policies included herein.
